Century Textiles & Industries has decided to retain a token presence in shipping business owing to the record freight rates that are prevailing now. The company, which had earlier decided to exit the business, has now decided against selling its last ship MV **ADITYA GAUTAM**, a 1994-built handymax bulk carrier of 43,815 dwt, for the time being. The earlier plan was to sell the ship in current fiscal.

43,814-dwt Panamanian bulk carrier cargo M/V **NEW FLAME**, loaded with scrap metal, collided with Danish tanker M/V **Torm Gertrude** loaded with 37,000 tons of fuel off the coast of Algeciras and Gibraltar on the morning of Aug. 12. M/V **New Flame** suffered flooding in No. 1 and 2 holds and began sinking at the bow, which is now resting on a reef. M/V **New Flame**'s crew of 23 abandoned ship.

Aug. 12 2007

Panamanian flagged 43,815 DWT bulker, the M/V **NEW FLAME**, Newark, New Jersey for Iskenderun, Turkey with 23 crew & scrap - In Collision early Aug. 12 with -- Danish flagged 46,362 DWT double-hull product carrier M/T **TORM GERTRUD**, Augusta, Italy for U.S. with 37,000 tons of gasoline . M/V **New Flame** sunk in shallow water less than a mile from Gibraltar. A.; 23 evacuated and the maritime authorities in Gibraltar and Spain are supervising salvage plans which are presently being developed by Tsavlis under an LOF.

M/V **NEW FLAME** remains half-sunk one km. off Punta Europa, with her prow supported on the sea bed. Spain is providing assistance to Gibraltar in the salvage operation to safely remove the 750 tons of fuel the ship is carrying in its tanks, and has sent teams of specialized divers from Algeciras & Galicia.

Stricken cargo M/V **NEW FLAME**, which this morning was sinking off Europa Point Gibraltar, later broke in two. The ship had been grounded following a collision with another vessel in Aug. With a salvage tug in the area, half the ship is now expected to sink. The ship was carrying over 27,000 tons of scrap from New York to Turkey when it collided. Spanish authorities nearby claim that fuel oil found on 2 beaches in the Algeciras area on the other side of the bay proceed from M/V **NEW FLAME**, but this is rejected by the Gibraltar Government.
