Tsakos Energy Navigation Ltd. (NYSE: TNP) announced the sale of the 1998-built 107,181 dwt Aframax tankers Maria Tsakos and Athens 2004 to an independent Greek-based operator. The Maria Tsakos will be delivered to her new owners on July 11, 2007 resulting in a \$31 million capital gain that will be recorded in the third quarter of this year. The Athens 2004 will be delivered in the beginning of the fourth quarter resulting in an additional \$31 million capital gain to be recorded at that time. After the repayment of related debt associated with the two vessels, approximately \$50 million in total cash will be released.

The US\$400 barrier was breached this week with the sale of the New Shipping controlled Aframax "NEW PAROS" which achieved region US\$408 per LWT basis delivery to Pakistan in a 'Gas Free for Hot works' condition. This is likely to spark the interest of other Tanker owners who are willing to clean up their old ladies and deliver them to the Sub-Cont.
