Vessel suffered main engine failure near the Isle of Scilly. Grounding could be avoided by the UK tug ANGLIAN PRINCE (Maritime & Coastguard Agency (MCA)) towing **HEIKE** to Falmouth.

The 396 teu vessel has been chartered by the new company Swan Container Lines Ltd., Isle of Man providing weekly departures on the route Hamburg - Bremerhaven - St. Petersburg. Swan Container Lines is a joint venture of NC Services Ltd., Far Eastern Shipping Co., Eurogate International & Döhle Schiffahrtslinien Agentur. AK 09 & 10/2003

The newly founded Swan Container Line LTD. of Douglas, Isle of Man will start its weekly liner service between the FCT Terminal in the Seaport of St. Petersburg to Terminals in the Seaports of Hamburg and Bremerhaven on the 12th of September with the sailing of the containership MV "**HEIKE**".

The shareholders of Swan Container Line LTD., each with 25%, are Eurogate International GmbH, Doehle Schiffahrtslinien-Agentur GmbH & Co. KG, FESCO (Far Eastern Shipping Company) and NC Services LTD.
