GENERAL VESSEL INFORMATION:

At the end of the year (1999), Lauritzen Kosan acquired the two fully-pressurised gas carriers, the 4,000 cubic-metre **KINNA KOSAN**, built in 1989, and the 6,500 cubic-metre KAISA KOSAN, built in 1992. Both vessels, which have been chartered back to the seller for a limited period, will be employed in Lauritzen Kosan's future operations in the Far East.

LPG/C **KINNA** was delivered from Lauritzen Kosan of Denmark with a three-year bareboat charter back to seller. The vessel is a pressurized gas carrier of 4.000 cbm built in 1989 by Korea Shipbuilding. The vessel will be owned by VM I AS, a 100% owned subsidiary of Viken Marine AS, and is the first gas carrier in Viken's fleet.
